Further, in compliance with the Notice dated November 5, 2021, issued by the Office of Crime Branch, Gautam Buddh Nagar (intimation of which was filed by the Company with Stock Exchanges on November 6, 2021, *copy attached*), the Company has communicated to Yes Bank Limited that such an action of Yes Bank Limited will tantamount to breach of the said Notice issued by the Crime Branch.

Vide the said Notice, the Company has been informed that Crime Branch has issued a Notice under Section 102 of the Cr. P.C, 1973, to Yes Bank Limited ('YBL'), restricting YBL from dealing in and/or exercising any rights over 44,53,48,990 Equity shares of the Company held by YBL, till completion of the investigation or till further orders.

Further, the Crime Branch has also directed that the Company shall ensure compliance of the above direction, till completion of the investigation or till further orders.
